



GUIDANCE ON DANGEROUS GOODS DAILY PERMIT APPLICATION

PERATURAN DAN PANDUAN MENGISI BORANG PERMOHONAN MEMBAWA MASUK/KELUAR/TRANSIT BARANGAN BERBAHAYA MELALUI UDARA MENGGUNAKAN SISTEM BLESS

1. Permohonan hendaklah dibuat di laman web BLESS <https://www.bless.gov.my/bless/action/login?show>. Bagi permohonan daripada Agensi Kerajaan, permohonan untuk mewujudkan ID BLESS hendaklah dihantar ke ops.dg@caam.gov.my
Applications must be made on the BLESS website. For applications from government agencies, a request to create a BLESS ID must be sent to ops.dg@caam.gov.my.

2. Setiap permohonan **MESTILAH** mempunyai *Proper Shipping Name* (Nombor UN) yang mewakili **SATU (1)** barangan berbahaya sahaja. Permohonan ini hanyalah terpakai untuk permohonan membawa barangan berbahaya bagi **Class 1, Class 7 dan Senjata api (termasuk aksesori & alat ganti senjata)**.
Each application MUST include a Proper Shipping Name (UN Number) representing only ONE (1) dangerous good. This requirement applies only to applications for the carriage of dangerous goods in Class 1, Class 7, and firearms (including accessories and spare parts).

3. Salinan dokumen-dokumen berikut (salinan hendaklah **jelas, terang dan masih sah tempohnya**) yang berkaitan dengan sesuatu permohonan hendaklah disertakan bersama:-

4. **JIKA PERMIT DARIPADA PIHAK POLIS ATAU LPTA TIADA**, Surat Kebenaran atau Surat Pengecualian daripada Pihak Berkuasa yang berkenaan mesti disertakan dan masih sah tempohnya.
If there is no permit from the police or LPTA, a valid Letter of Authorization or Letter of Exemption from the relevant authority must be included
5. Sekiranya individu/syarikat/jabatan yang memohon untuk membawa masuk/keluar/transit sebagai agen daripada syarikat penerima kargo maka **Surat Akuan Kebenaran** daripada individu/syarikat/jabatan penerima kargo mestilah disertakan bersama.
*If the individual/company/department applying to bring in/out/transit as an agent from the cargo receiving company, the **Letter of Authorization** from the cargo receiving individual/company/department must be included.*
6. Pemohon yang membawa/mengimport/meneksport senjata api dan peluru **bagi pihak Jabatan Kerajaan** seperti Polis dan Tentera dengan menggunakan '**End User Certificate**' perlu mendapatkan permit untuk membawa/mengimport/meneksport daripada pihak PDRM (surat PDRM KPN(PR)X/X/X/X bertarikh X/X/XXXX).
*Applicants who carry/import/export firearms and ammunition on **behalf of Government Departments** such as the Police and the Army using an '**End User Certificate**' need to obtain a permit to carry/import/export from the PDRM (PDRM letter KPN(PR)X/X/X /X dated X/X/XXXX).*
7. Tarikh **shipper's declaration** yang ditandatangani mestilah **tidak melebihi daripada satu (1) bulan** dari tarikh penerbangan. Bagi **shipper's declaration** yang ditandatangani di Malaysia, salinan sijil kursus DGR perlu disertakan bersama borang permohonan.
*The signed date of the **shipper's declaration must not exceed one (1) month** from the date of the flight. For the shipper's declaration signed in Malaysia, a copy of the DGR course certificate must be included with the application form.*
8. Barang-barang ini mestilah dikeluarkan secepat mungkin atau dalam masa **24 jam** daripada masa ketibaan/pendaratannya.
*The items must be removed as soon as possible or within **24 hours** of their arrival/landing.*
9. Adalah menjadi tanggungjawab pemohon untuk memaklumkan kepada Pihak Berkuasa Penerbangan Awam Malaysia berhubung sebarang pindaan butiran (**terpakai untuk tarikh dan no. penerbangan sahaja**) yang telah dinyatakan terhadap permohonan yang telah diluluskan.
*Applicants need to inform the Civil Aviation Authority of Malaysia regarding any amendment of details (**applicable to date and flight no. only**) to the submission that has been approved.*
10. Sebarang pindaan terhadap tarikh penerbangan hendaklah dibuat **tidak lebih 7 hari dari atau sebelum tarikh penerbangan asal yang telah diluluskan** dan disertakan dengan surat rasmi dari individu/syarikat/jabatan yang berkenaan.
*Any amendment to the flight date must be made no more than **7 days from or before the original flight date that has been approved** and accompanied by an official letter from the relevant individual/company/department.*
11. Setiap permohonan individu/syarikat/jabatan yang membawa barang-barang bahaya melalui udara adalah tertakluk kepada peraturan/undang-undang yang terpakai di dalam negara ini.
Every individual/company/department application that carries dangerous goods by air is subject to the applicable regulations/laws in this country.

12. Kegagalan untuk melengkapkan borang ini sepenuhnya boleh mengakibatkan kelewatan dalam memproses permohonan.

Failure to complete this form completely may result in a delay in processing the application.

13. Setiap permohonan melalui pengisian borang ini bukan satu kelulusan rasmi daripada Pihak Berkuasa Penerbangan Awam. Kelulusan permohonan barangan berbahaya akan diberikan setelah Pihak Berkuasa Penerbangan Awam berpuas hati dengan segala prosedur yang diambil oleh pemohon.

Each submission in this form is not an official approval from the Civil Aviation Authority. The approval of the application of the dangerous goods will be given after the Civil Aviation Authority is satisfied with all the procedures taken by the applicant.


14. Setiap permohonan akan dikenakan caj sebanyak **RM 100.00** bagi permohonan baru (**NEW**) dan **RM 50.00** atas pindaan terhadap tarikh penerbangan (**REQUEST FOR CHANGE**). Semua caj yang dikenakan adalah berdasarkan Peraturan-Peraturan Penerbangan Awam (FI DAN CAJ) 2016. Bukti pembayaran hendaklah dikepilkan di dalam permohonan BLESS.

*Each application will be charged **RM 100.00** for a new application and **RM 50.00** for an amendment to the flight date (**REQUEST FOR CHANGE**). All charges are based on the Civil Aviation Regulations (FI AND CHARGES) 2016. Proof of payment must be attached to the submission in BLESS.*




