HELICOPTER ACCIDENT NEAR BENTONG, PAHANG

PUTRAJAYA - The Civil Aviation Authority of Malaysia (CAAM) confirms an accident involving a Bell 206L4 helicopter, registration number PK-ZUV at a helicopter landing site near Bentong, Pahang, today at 10.26 AM. The helicopter, leased and operated by MHS Aviation Berhad, was conducting an aerial work flight. The last information was reported by the operator at 10.18 AM to Flight Information Service (FIS) at Kuala Lumpur Air Traffic Control Centre (KLATCC) notifying that the helicopter is returning to the landing site.

The accident involved one ground crew while the helicopter pilot is reported to be safe. Further investigation will be conducted by the Air Accident Investigation Bureau under the Ministry of Transport Malaysia in accordance with Part XXVI Civil Aviation Regulations 2016.

KEMALANGAN PESAWAT HELIKOPTER DI BENTONG , PAHANG

PUTRAJAYA - Pihak Berkuasa Penerbangan Awam Malaysia (CAAM) mengesahkan kemalangan melibatkan sebuah helikopter Bell 206L4, nombor pendaftaran PK-ZUV di tapak pendaratan helikopter berhampiran Bentong, Pahang, hari ini pada jam 10.26 pagi. Helikopter yang disewa dan dikendalikan oleh MHS Aviation Berhad itu sedang menjalankan penerbangan kerja keudaraan. Informasi terakhir yang diterima daripada pihak operator pada jam 10.18 pagi kepada Perkhidmatan Maklumat Penerbangan (FIS) di Pusat Kawalan Trafik Udara Kuala Lumpur (KLATCC) melaporkan bahawa helikopter akan mendarat di tapak pendaratan.

Kemalangan dilaporkan melibatkan seorang kru darat manakala seorang juruterbang helikopter berkenaan dilaporkan selamat. Siasatan lanjut akan dijalankan oleh Biro Siasatan Kemalangan Udara di bawah Kementerian Pengangkutan Malaysia mengikut Bahagian XXVI Peraturan Penerbangan Awam 2016.
